1 **PLEASE TAKE NOTICE** that on August 7, 2026, at 9:30 a.m., or as soon thereafter
2 as counsel may be heard, in Department 38 of the above-entitled Court, located at 111
3 North Hill Street, Los Angeles, California, before the Honorable Maureen Duffy-Lewis, Judge
4 Presiding and Specially Assigned, the Main San Gabriel Basin Watermaster ("Watermaster")
5 will petition the Court for an order approving the intervention of San Gabriel Band of Mission
6 Indians Led by the Gabrieleno Tongva Tribal Council, as a party defendant herein. The
7 Petition of Watermaster is based upon the following facts:

8 Pursuant to Paragraph 57 of the Amended Judgment herein, San Gabriel Band of
9 Mission Indians Led by the Gabrieleno Tongva Tribal Council executed a Stipulation Re
10 Intervention After Judgment. (The original Stipulation is attached hereto as **Exhibit "A"**).

11 Paragraph 57 of the Amended Judgment provides as follows:

12 "57. Intervention After Judgment. (Prior Judgment Section 49)

13 Any person who is not a party or successor to a party and who
14 proposes to Produce water from the Basin or Relevant Watershed,
15 may seek to become a party to this Judgment through a Stipulation
16 For Intervention entered into with Watermaster. Watermaster may
17 execute said Stipulation on behalf of the other parties herein but
18 such Stipulation shall not preclude a party from opposing such
19 Intervention at the time of the Court hearing thereon. Said
20 Stipulation For Intervention must thereupon be filed with the Court,
21 which will consider an order confirming said Intervention following
22 thirty (30) days' notice to the parties. Thereafter, if approved by the
23 Court, such Intervenor shall be a party bound by this Judgment and
24 entitled to the rights and privileges accorded under the Physical
25 Solution herein."
